**Late bids will not be accepted and those forwarded by electronic mail will not be considered.**
5. Bids will be opened in the Conference Room of the Ministry on **Monday 30 September 2019 at 13 40 hours** in the presence of Bidders/Bidders’ representatives who choose to attend.
6. A pre-bid meeting will be held on **Tuesday 10 September 2019** in the Conference Room of the Ministry of Technology, Communication and Innovation at Level 7 SICOM Tower at **10.00 hours**. Potential bidders/bidders’ representatives are strongly advised to attend.
